The fine print:

GENERAL ENROLLMENT & PARTICIPATION:

As the Parent/Guardian of an enrolled Tiptoes & Taps participant, I understand that my child's enrollment fees must be received in full prior to my child participating in any program.

Payments can be made by cash or cheque only. I understand that any NSF cheque will be subject to a \$35.00 service charge.

LATE PICK-UP:

Children participating in any program may be dropped off no earlier than 5 minutes before the program begins. Children must be picked up promptly at the end of the class as the period of time between classes is required as preparatory time for the instructor. Should a parent arrive late to pick up their child, the fee will be \$5.00 for every 5 minutes.

CANCELLATION/REFUNDS:

I the Parent/Guardian accept that if, for any reason, I must withdraw my child from participating in the program, I will receive a full refund if such cancellation is received **TWO (2) weeks** prior to the start of the program in which my child is registered. Any cancellation received **less than TWO (2) weeks** prior to the start of the program may be subject to a 50% refund if the spot is filled by the start date. Should my child withdraw once the program begins, I will waive my entitlement to any refund or reimbursement. Further, I accept that any days missed cannot be refunded or reimbursed.

ILLNESS:

If my child becomes ill during the day the program, I understand that I will be immediately notified and must arrange for the pick up of my child. I understand that I will not be reimbursed for any sick days.

EMERGENCY MEDICAL TREATMENT:

In the event of any accident or illness involving my child while attending a Tiptoes & Taps program, I understand that the instructor will make every effort to contact me and/or my emergency contact person. Should the instructor be unable to make such contact, I hereby give my consent to Tiptoes & Taps to act on behalf of my child in the event of such an emergency and, further, to be transported, assessed and treated in a hospital if necessary.
